PROJECT OVERVIEW

The Senior Mobility Program (SMP) offers transportation alternatives for seniors in addition to local fixed-route buses or ADA paratransit (OC ACCESS) services. Participating cities and non-profit participants may receive both funding and vehicles to design a program that best fits the needs of seniors 60 years and older in their communities.

PROJECT FUNDING

Funding for the city participants in the SMP comes from Measure M, Orange County's half-cent sales tax for transportation improvements. Under the Measure M funding umbrella, Project U provides funding for senior/disabled programs including the SMP. One percent of net revenue is allocated to the SMP, and participating cities receive their allocation based on their share of the county's population of seniors over 60 years of age.

Funding for non-profit participants in the SMP comes from sales tax revenues.

To date, 32 cities and three non-profit organizations are SMP partners. Contacts for local SMP partner agencies and cities are listed on the back of this document.
